4. Description of the goal

5. The main points of the policy plan

The objectives of the Foundation are:

- c) development cooperation,
- d) the development of art and music, and
- e) providing assistance to victims of crime and
- f) to perform all such further acts and activities as are in the widest sense connected therewith, incidental thereto and/or which may be conducive thereto.

The Foundation shall make every effort inter alia to attain and accomplish its objectives by:

- a) organizing and implementing care activities for young people of socially disadvantaged and underprivileged parents;
- b) conducting educational and life skills workshops for socially disadvantaged or underprivileged youth and adults;
- c) conducting awareness and prevention campaigns to curb the occurrence of physical, mental and sexual violence;
- d) providing support for victims of physical, mental, and sexual violence;
- e) conducting volunteer services at home and abroad;
- f) developing cooperation through the implementation of various projects and programs, including,
 - early childhood development programs,
 - education,
 - development of the arts and music;
 - sponsorship programs for orphans and vulnerable children,
 - programs for victims of sexual abuse,
 - awareness campaigns,
 - promotion of equality and providing quality and
 - equality in education and
 - development for underprivileged children, youth and families;
 - cooperation with and support of public corperations or other non-profit organizations abroad, particularly in South Africa and Brazil, but also elsewhere, in the form of project work, assistance relationships, volunteer services, and material and/or financial support.
